1. Healy Consultants fees to efficiently and effectively complete Slovakia stock company registration within [3 weeks](#) by **i)** choosing the optimum regulatory license for our Client's business activities; **ii)** reserving a company name with [District Court](#); **iii)** settling our accountant and lawyer fees and **iv)** preparing a high quality joint stock company incorporation application for [District Court](#);

All [engagement fees](#) (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of a [detailed project plan](#), mapping out [deliverables](#) by week throughout the engagement term;



Every week during the engagement, Healy Consultants will email our Client a [detailed status update](#). Our Client is immediately informed of engagement problems together with solutions. To comply with this statutory requirement, Healy Consultants' Slovakia office will be the registered office address for your joint stock company. Thereafter, this address will be used to receive government correspondence including **i)** tax letters **ii)** notice of the legal annual return; and **iii)** all government communications. Most of our Clients wish to place [Healy Consultants' office address](#) on invoices, contracts, websites and business cards;
3. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of government costs include **i)** reserving the company name with the [District Court](#); **ii)** preparation of company deeds and articles of association; **iii)** applying for registration at the [District Court](#); **iv)** notarizing company deeds, and **v)** preparation of the company seal. Following engagement completion, Healy Consultants will refund our Client any excess of funds received over actual Government costs paid;

The banks enjoys ultimate power of approval of corporate bank account applications. Consequently, guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation and submission of a high quality bank application that maximizes the likelihood of approval. 5. In accordance with [Slovakia Tax Laws](#), each entity must register for corporate tax and VAT if the projected annual turnover exceeds €50,000 at the [Ministry of Finance](#);
 6. For an active trading joint stock company, these [accounting and tax](#) fees are an estimate of Healy Consultants fees to efficiently and effectively discharge your annual company accounting and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants will more accurately advise accounting and tax fees. For a dormant joint stock company, Healy Consultants fees are only €950;

The Slovak JSC may only be subject to statutory audit if it meets either two of the following conditions: **i)** its annual net turnover exceeds €2 million; **ii)** its total assets exceed €1 million and **iii)** has more than 30 employees. Such audit is however mandatory when the company is listed on a stock exchange;
16. If required, Healy Consultants will be pleased to assist your firm secure employee [visa](#) approvals. Our fee is €4,950 for the first employee, €2,950 for the second employee, €1,950 per employee thereafter. Our employee visa fees includes preparation of a quality visa application and submitting to the correct Government immigration officers. The Government enjoys ultimate power of approval of visa applications. Consequently, guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation and submission of a high quality immigration visa application that maximizes the likelihood of visa approval;
17. Some of our Clients request Healy Consultants to provide temporary shared [office space](#) for 6 months until their preferred business premises is found. If your Firm requires this service, our one-time fee is €950. Monthly rental thereafter is paid directly to the landlord, independently of Healy Consultants;

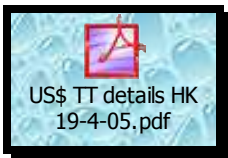
